## **POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON 23 MAY 2025**

The board (the “**Board**”) of directors (the “**Directors**”) of Fulu Holdings Limited (the “**Company**”) is pleased to announce the poll results of the annual general meeting (the “**AGM**”) held at 14th Floor, Building B27, Optics Valley Financial Port, No. 77 Guanggu Avenue, East Lake High-tech Development Zone, Wuhan, Hubei Province, the PRC on Friday, 23 May 2025 at 11:00 a.m.

References are made to the circular (the “**Circular**”) and the notice of the AGM (the “**Notice**”) of the Company both dated 28 April 2025 regarding the AGM. Unless the context otherwise requires, capitalized terms used herein shall have the same meanings as those defined in the Circular.

As at the date of the AGM, the total number of the issued Shares is 408,640,887 Shares, and the total number of issued Shares, excluding treasury shares, is 406,020,887 Shares. Furui Holdings Limited, a wholly-owned subsidiary held by Maples Trustee Services (Cayman) Limited, an independent third party in its capacity as the trustee of a trust established by the Company in relation to the restricted share unit scheme of the Company adopted by the Board on 19 August 2021, held 3,342,933 Shares, representing approximately 0.82% of the issued share (excluding treasury shares) capital of the Company as at the date of the AGM, and was required to abstain and did abstain from voting on all resolutions proposed at the AGM under Rule 17.05A of the Listing Rules. Accordingly, the total number of Shares entitling the Shareholders to attend and vote on all resolutions at the AGM was 402,677,954 Shares. Save as disclosed above, (i) there were no restrictions on any Shareholders casting votes on any resolutions at the AGM; (ii) none of the Shareholders who were entitled to attend the AGM had to abstain from voting in favor of any resolutions at the AGM as set out in Rule 13.40 of the Listing Rules; (iii) none of the Shareholders was required to abstain from voting on any resolutions at the AGM under the Listing Rules; and (iv) none of the Shareholders had stated his/her intention in the Circular to vote against or to abstain from voting on any resolutions at the AGM.

Computershare Hong Kong Investor Services Limited, the Company's Hong Kong share registrar, was appointed as the scrutineer for vote-taking at the AGM.
